Schroder International Selection Fund – EURO Short Term Bond

The board of directors of Schroder International Selection Fund (the "Company") has decided to adapt the expected level of leverage of Schroder International Selection Fund – EURO Short Term Bond (the "Fund").

The Fund's expected level of leverage disclosed in the Company's prospectus will increase from 150% of the total net assets to 200% of the total net assets. This increased number more accurately reflects how the leverage is measured and takes into account certain financial derivative instruments (specifically FX forwards).

The Fund's expected level of leverage, which is reflected in the Company's prospectus, is being changed from:

"Expected Leverage

150% of the total net assets"

To:

"Expected Leverage

200% of the total net assets"

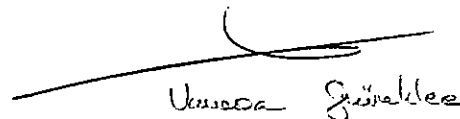
